Odessa (UKR), 07- 09 May 2012

GENERAL REGULATIONS

PARTICIPATION

1. Only the National Federations or Committees duly affiliated to FILA for the year 2012 can participate in the event. They are fully responsible for entering their athletes within the deadline.
2. National Federations or Committees are responsible for their competitors' insurance through national or international FILA licence.
3. Participation per country per weight category is not limited.
4. Each competitor must be 20 or older. Competitors aged 18 and 19 are allowed to participate upon presentation of a medical certificate. Age and nationality will be checked with the passport at the weigh-in.
5. To be eligible, MMA fighters must present negative results of HIV and Hepatitis B & C tests no older than 3 months prior to the event, have not engaged in a professional MMA fight 1 month prior to the event, and have not suffered a knockout with damage to the brain 2 months prior to the event.
6. Preliminary entries (number of participants) for grappling and amateur MMA must be sent to Ukraine Pankration Federation and FILA before **24 April 2012**.
7. Final entries (participants' name) for grappling and amateur MMA must be sent to Ukraine Pankration Federation and FILA before **05 May 2012**.
8. Proposals of pro MMA fighters for the super fights must be sent to Ukraine Pankration Federation and FILA before **18 April 2012** along with their complete record, biography, and photograph in high resolution.
9. Upon analysis of the candidates' profiles, Ukraine Pankration Federation and FILA will match the fighters and send confirmation to their respective National Federation or Committee by **25 April 2012**.
10. Athletes competing in grappling and amateur MMA will be requested to pay a participation fee of 50 EUR per style to the organiser.
11. The organiser will cover full accommodation for all participants, plus 1 coach and 1 referee per team.
12. The delegations will be welcomed by the organiser upon their arrival in **Odessa International Airport** and will be driven to the hotel to proceed with accreditation.
13. Competitors are under the exclusive responsibility of their National Federation or Committee through their respective coaches. Any breach of the rules will be sanctioned according to the FILA Disciplinary Regulations.

TECHNICAL CONDITIONS

1. The competition will run according to the FILA official rules on 3 FILA approved mats.
2. The competition will take place in the following weight categories for all styles: Men 66, 71, 84, 92, + 92kg. No weight tolerance will be accepted.
3. Each competitor will be requested to undergo a medical examination before the official weigh-in, during which his/her competition uniforms will be inspected for compliance as well.
4. The drawing of lots for position in the brackets will be done manually at the time of weigh-in.
5. Competitors who forfeit a match without proper medical certificate will not be allowed to proceed throughout the tournament (even in other styles) and will be withdrawn from the final ranking.
6. Grapplers must wear a FILA approved competition uniform, that is: board shorts of neutral colour and a tight fitting short sleeve or long sleeve rashguard. The first grappler called shall put on an overall red uniform and the second an overall blue uniform.
7. Amateur MMA fighters must wear a FILA approved competition uniform, that is: board shorts, a mandatory rashguard, head guard, 8oz MMA gloves, knee pads, and shin-instep guards. The first competitor called shall wear a red uniform and protections and the second one a blue uniform and protections.
8. Pro MMA fighters will be provided with FILA approved gloves.
9. In addition, amateur and pro MMA fighters are required to wear a groin guard and a mouth guard.
10. The following prizes will be given to each weight category in grappling, amateur MMA and pro MMA:

1 st place	1 gold medal, certificate and 1000 USD
2 nd place	1 silver medal, certificate and 500 USD
3 rd places	2 bronze medals, certificates
5 th –10 th places	certificates

REFEREES

1. Only the FILA certified referees with a valid 2012 licence may work in the competition.
2. All referees must wear black flat-front pants, black plimsolls, and the official FILA shirt and accessories.
3. All referees must attend the referees' course preceding the competition.
4. In accordance with the FILA regulations, a National Federation or Committee which enters more than 3 competitors has the obligation to enter a referee as well. Failing to do so, a penalty of 1000 CHF will be imposed to the National Federation or Committee and will be used to indemnify the referees in attendance.
